Minutes of a Meeting of Steventon Parish Council held on Tuesday 6th August 2019 in the Millennium Room of Steventon Village Hall

1. APOLOGIES FOR ABSENCE

Apologies were received from Cllr M Barber (VWH)

2. PRESENT

Dr C Wilding Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Rice, Mr M Stimpson-Tame and Mr M Tucker. Mrs A Einon (Parish Clerk) and Cllr M Fox-Davies were in attendance. There were five members of the public present. Dr Wilding welcomed Mr Martin Stimpson-Tame to the Parish Council.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

No declarations were received.

4. PUBLIC PARTICIPATION

4.1. Reservoir

Gard had sent a freedom of information request to Defra regarding the statements made by Yvonne Constance in parliament. Response is due by 31st August.

4.2. Ock Bridge Abingdon

The Parish Council were asked to support a suggestion that the design of Ock Bridge be changed to remove the current pavement and build a footbridge alongside. The aim to enable three lanes of traffic thus speeding the current traffic queues. It was felt that this suggestion should be addressed to Abingdon Town Council and OCC Highways.

4.3. Truck

The traffic provisions had seemed to work well this year. Directional signs had been out well in advance and there were less lost bodies. Litter had also been better controlled, and bags put out along the Causeway. Cars parked in the village had been a problem particularly in Castle Street and around the Church. The letter from Truck to residents, concerning one way traffic etc required wider distribution. A lot of the village was unaware of the restrictions, however the flow worked well.

4.4. Level crossings

The notices to switch of engine while waiting at the crossing were not clearly visible.

4.5. Causeway verge repairs

Network Rail planned to repair the ditches and verges along the Causeway in September.

4.6. Pedestrian crossing - Hanney Road

Nothing further had been heard from Highways regarding the surveys they need to do to clear the zebra crossing. Mr Fox-Davies had chased Highways for a response.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Cllr Mike Fox-Davies –

Oxfordshire County Council starts planning to replace Kennington bridge Oxfordshire County Council has announced that the A423 Kennington Bridge is to be replaced at an estimated cost of around £40m. The bridge and road will remain open for at least two years before construction work starts while design takes place.

More charging points to support electric vehicles

The electric car revolution is set to continue in Oxfordshire thanks to a successful county council bid for a slice of a £37m government fund.

Work to start on Bicester's new 600-pupil school

Around 88 per cent of children and their parents achieved their first choice of school in Oxfordshire in 2019 despite continued rising demand for places

Radical changes that improve the lives of families are set to be introduced in Oxfordshire

A pioneering approach that has radically changed the way children's social care operates in Hertfordshire is set to be adopted by Oxfordshire County Council.

Council seeks out more local foster carers

Oxfordshire County Council's cabinet has agreed a £1m investment in its in-house fostering service, which will increase the number of local carers and reduce the number of children who are placed with carers outside of Oxfordshire.

Free school transport for disabled young people is retained

Young people with special education needs and disabilities will continue to be funded by Oxfordshire County Council, following a decision by Cabinet members on Tuesday, 16 July.

Cllr Fox-Davies agreed to investigate the adoption of the roads on new estates in the village by Highways.

9.4 Recreation and Open Spaces – Trees, Greens, Waterways, Footpaths, Playground, Sports Hall. JC, CB, CD, RG, CW, JR,MT, MST

Ben Border and David Cookson, VWH, had met with Dr Wilding, Mrs. Brickwood and the Clerk on Wednesday 3rd July, they raised concerns that the S106 monies available would not be spent in time, and asked what the Parish planned for the funds. Planned expenditure included, upgrade the MUGA, resurface the play area at St Michaels road and to install a zip wire. Feedback from Damascus group had been received. Other possible uses: community footpaths, village map, tree planting. There is also money available for outdoor gym equipment and art. The working group to draw up a schedule of the work required and obtain quotes.

Action 19/08/04: Recreation and Open Spaces

Map of grass cutting areas agreed with Ben Griswold was thought to be with Mr Bosley, it was required to negotiate prices with Sarinc.

Action 19/08/05: Clerk

The Ash tree on the corner of Mill Street and Castle Street had died. The Clerk had arranged for it to be removed by Russell Gooding on Wednesday 7th August. The wood would be collected by Sarinc for distribution to the village. Notification would be sent to the Vale Tree Officer as it is in the conservation area.

9.5 Village Infrastructure & Resilience – Railway, Roads, Drains JB, RG, JR, CW. MT. Resilience volunteers Rosemary Howden, Simon Holloway

Meeting of the railway section on 18th July. Modeling to save the bridge was still needed to be ready in case the appeal was reinstated; it was currently in abeyance until 30th September. If reopened there would be six week's notice to prepare a response. Speed restrictions for 387 engines was discussed, they may need to go slower through the village. Investigate and do a train count. A proposal that another operator may run trains from Wales to London. Alternate solutions: discuss with the Vale's experts the extent of track lower possible. Bridge jacking evidence not available, this could bring in support from Historic England and the Conservation officer. Possibilities to upgrade 387 trains with different pantographs and/or higher spec cables though Steventon.

Emergency vehicles access to the village. Propose a letter to Network Rail, OSR, OCC, Fire Brigade, South Central ambulance and Police. Mr Green to draft and circulate to Parish Councillors for comments.

Zebra crossing traffic count

OCC, despite our supplying surveys of traffic and footfall, have now decided to do a 7-day 24/7 survey of the traffic on Hanney Road. Drawings have been done on the design criteria and it will be out for consultation

Catherine Brickwood and Chris Wilding had attended the Policy writing workshop on 10th July, organized by Vale. Changes to guidance have complicated the route on content and submission of the Neighbourhood plan. Few had attended, and an offered follow up meeting had not been taken up by the other attendees. The Clerk to write to request a meeting with Robyn Tobutt, Planning Policy Officer (Neighbourhood) Planning South Oxfordshire and Vale of White Horse District Councils. Ashbury's plan was recommended as guidance.

A quote from Bluestone Planning to complete the application for a grant from Locality, apply to the Vale and complete the plan for submission had been received for £11,610. The steering group to meet on Thursday 15th August, to discuss policies, quote and possibly meet with Sharon Brentnall of Bluestone.
