Minutes of a Meeting of Steventon Parish Council held on Tuesday 7th January 2020 in the Millennium Room of Steventon Village Hall

1. APOLOGIES FOR ABSENCE.

Apologies had been received from Mrs C Denton and Cllr Mike Fox-Davies.

2. PRESENT

Dr C Wilding Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mr R Green, Mr J Rice, Mr M Stimpson-Tame and Mr M Tucker. Mrs A Einon (Parish Clerk) was in attendance. There were ten members of the public present.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

4. PUBLIC PARTICIPATION

4.1. **Cllr Mike Fox-Davies** had unfortunately been taken ill and would not be able to attend Parish Council meetings until recovered. All present sent good wishes for quick recovery and thanks for his help to date.

4.2. **GARD**

Ofwat neither approved or not Thames Water and Affinity proposals. It is yet to be proven that any of the proposals are justified. Ofwat strategic study on south east water has allocated 450 million to investigate, however there appears to be no independent investigators just the water companies. Thames Water has until 2021 to respond to Ofwat. Gard are encouraging all interested parties to register as stakeholders. GARD, CPRE and Drayton parish council have been accepted.

4.3. Planning application behind 31-33 The Causeway

The decision date on the Vale website was 11th December. Further data had been submitted in support of the application. Objections by the Environment Agency and the Waste Team appeared to have been withdrawn. The ward member Cllr Matthew Barber would have to object to the application, which he has previously agreed to do, for this to go to Planning Committee rather than be decided in house.

4.4. Abotts Mead

Three burglaries and attempted car theft has resulted in frequent police presence and is of serious concern to the residents. Dr Wilding agreed to contact our District Councillor Matthew Barber for information on increased crime and police support.

4.5. High Street site

Previously Rainbow colour and Magnox building, the land has been sold to a Somerset based developer.

4.6. Causeway ditches

The Causeway ditches had again been crushed by a lorry after Network Rails repairs. OCC had still done nothing to support the road or the repair the lamp post which is at an acute angle.

13.1. Applications

13.1.1 P19/V3215/FUL Land between 'The Furrows' and 26 Stonebridge Road Stonebridge Road Steventon OX13 6AS. Erection of a detached dwelling with integral garage (resubmission of P15/V1305/FUL)

Object. The proposed is an over development for the size of the plot which will dominate the neighbouring properties and the road. A three storey property on a road predominately two store and bungalows. The access is on a sharp bend which is dangerous as used as a rat run by commuters. A potentially five bedroomed house, squashed in a narrow plot overshadowing neighbours and does not fit with the design of the road. Car parking provision for only two cars, likely to lead to on road parking obstructing the bend.

13.1.2 P19/V2150/HH 85 Hanney Road Steventon Abingdon OX13 6AN. Garden building to replace the existing

Object Insufficient information. Appears to be a three roomed property replacing a shed. It does not mention retrospective nor that there are unresolved enforcements on this building. The purpose is stated as a shed, but the building is seven metres by six metres and seven metres tall.
