Minutes of a Meeting of Steventon Parish Council held on Tuesday 3rd July 2018 in the Village Hall Millennium Room

1. APOLOGIES FOR ABSENCE

Apologies received from Cllr M Barber (VWH) and Cllr M Fox-Davies (OCC)

2. PRESENT

Dr C Wilding Chair, Mr J Bennett, Mr R Bosley, Mrs C Brickwood, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Spiller and Mr R Wilkinson. Mrs A Einon (Parish Clerk) was in attendance. There were nine members of the public

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

Mr Bosley and Mr Clark declared a non-pecuniary interest in that they are Trustees of the Parochial Charities.

4. PUBLIC PARTICIPATION

4.1. Miller Homes

Residents from the Miller Home estate attended the meeting to ask what could be done as the builders had now left site and the landscaping and roads had not been finished. The path to the bus stop had not been done. Maintenance fees had been collected but no details of who or when would be doing the work, had been circulated. Unfortunately, this was a problem being experienced on all the new estates. The Parish Council would write to the Vale Planning Department to raise an enforcement, but every resident needs to voice their complaints as well. As in the Linden Homes case in Cholsey to inform your MP and District Councillor's, both OCC and VWH.

4.2. Caravan in Stonebridge Road

The caravan was still in Stonebridge Road. Dr Wilding would communicate with the PCSO and Cllr Matthew Barber.

4.3. Bridge and electrification

The Planning Committee of the Vale will be discussing the application to demolish the bridge when Network Rail had responded to questions raised. Planning meeting now 1st August.

4.4. Development behind Bargus Close

Dr Wilding reported that he had made enquiries with the Vale of White Horse DC about any approaches regarding a development. He had been assured that no applications had been made or discussed.

4.5. Castle Street

The work by Thames Water in Castle Street is due to be finished on Friday. The quality of the infill had been inferior and had been reported to Huw Thomas (Project Manager). The surface was uneven, creating puddles and would break up in winter. The installation team would now move to Mill Street, where chaos was anticipated.

4.6. Travellers on Little Green

Mr Bosley and Dr Wilding were thanked for their work in moving on the travellers who had set up on the Little Green.

4.7. GARD - Derek Stork

The consultation period for Thames Water future programme had ended in April, there was a call for a second consultation. Thames Water response was due in August. Councillors Mike Fox-Davies and Richard Webber support the motion for a second consultation and the Vale was calling for a public enquiry. Support was still needed both from individuals and groups.

4.8. Road repairs

Dr Wilding reported that Gordon Kelman had walked around the Causeway south of the railway with the Conservation officer to agree materials and gabions. The work to the roadside ditch would be done in August he would investigate how close to the crossing work could be done before involving Network Rail. Mill Street banking and potholes would be repaired. Hanney Road would be shut on a Sunday to install the new chicane when agreement had been reached.
