Minutes of a Meeting of Steventon Parish Council held on Tuesday 5th June 2018 in the Village Hall Millennium Room

1. APOLOGIES FOR ABSENCE

No apologies had been received

2. PRESENT

Dr C Wilding Chair, Mr J Bennett, Mr R Bosley, Mrs C Brickwood, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Spiller and Mr R Wilkinson. Mrs A Einon (Parish Clerk) and Cllr M Fox-Davies(OCC) were in attendance. There were seventeen members of the public present.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting. There were no declarations.

4. PUBLIC PARTICIPATION

4.1. Speed bump School Close

The rubber speed bump in School Close had been removed and would not be reinstated.

4.2. Caravan in Stonebridge Road

The caravan had been reported to the PCSO who had promised to look into its removal.

4.3. Bridge and electrification

The Planning Committee of the Vale will be discussing the application to demolish the bridge when Network Rail had responded to questions raised. Likely to be the July Planning meeting.

4.4. Development behind Bargus Close

Residents of Bargus Close were very concerned about rumours of development between them and the railway. The Parish Council had no knowledge of any proposals. Dr Wilding agreed to investigate further.

4.5. Chicane and potholes

Cllr Fox-Davies informed the meeting that OCC Highways had agreed some resurfacing and for installation of the chicane. However, this would require closure of the Hanney Road for at least a day. He asked for feedback on the best time for a closure. The design of the chicane was raised as the current one is simply run over by the large lorries using the storage depot as there is insufficient space for them to negotiate the turns. The design agreed and funded by the Linden development was for a one lane exit near the current chicane giving priority to those leaving the village. The usefulness of the chicane was raised as it caused speeding to get there first and many near misses. It was stressed that it is essential for accidents to be reported to police as this data is used for decisions on actions relating to roads. No reports no action.

4.6. Truck

The numbers expected had returned to 15000 for this year. The travel plan indicated all traffic to go via Featherbed Lane. Pedestrians and the lost would still be in the village.

4.7. Storage Depot

The Parish had submitted a complaint to the Vale about the large lorries using the Hanney Road to access the Storage Depot at all hours of the day and night. The Vale had acknowledged and were investigating. A Technical Officer who had responded to a resident in Hanney Road had been amazed at the volume of traffic. Authority to use the Storage Depot at its present level was questioned. The traffic monitor would be used in the Hanney Road as near the chicane as possible.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Cllr Mike Fox-Davies

OCC and Cherwell District Council (CDC) are considering a proposal for shared service arrangements under a joint chief executive, while retaining separate councillor bodies, budgets and decision-making processes. The County Council had received a good Ofsted rating. Gill Sanders last month became the new Chairman of OCC. Teams are to be set up around people who need care in Abingdon and Wallingford as part of a £100,000 trial to be managed by a specialist Manchester based company called Wellbeing Teams. Only people who live within a five-mile radius of

those for whom they'll care will be recruited to the new teams. They just need to be able to offer up to 21.75 hours of time per week and have a clear commitment and pride in their local area and community.
