THE CAUSEWAY

Minutes of a Meeting of Steventon Parish Council held on Tuesday 4th June 2019 in the Village Hall Millennium Room

1. APOLOGIES FOR ABSENCE

Apologies were received from Mrs C Denton and Cllr M Barber (VWH)

2. PRESENT

Dr C Wilding Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mr R Green and Mr J Rice. Mrs A Einon (Parish Clerk) and Cllr Mike Fox-Davies (OCC) were in attendance. There were ten members of the public present.

Dr Wilding welcomed Mr John Rice to the Parish Council.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

Mr Rice had an interest in the Planning application for 59 The Causeway.

4. PUBLIC PARTICIPATION

David Cookson South and Vale gave information on the S106 money that Steventon had been awarded from the new developments. The restrictions on its use are very tight but the money needs to be spent or it will return to the developers. His department has been created to ensure that claims and payments are not delayed unnecessarily, previous attempts to get the money from the Vale have been onerous. The replacement system CIL will be much less restrictive and the money will come straight to the Parish Council. We will of course have to get more new builds to be eligible for CIL.

4.1. Demolition of the railway bridge

The proposed enquiry has been postponed until at least September while Network Rail investigate new models that have become available. Network Rail will attend the next meeting to the Parish Council on 2nd July to update.

4.2. Pedestrian crossing - Hanney Road

Nothing further had been heard from Highways regarding the surveys they need to do to clear the zebra crossing. Mr Fox-Davies agreed to chase them up and find out the situation. It is hoped for installation in the summer holidays.

4.3. Causeway/ Vicarage Road

Dr Wilding had been in communication with Network Rail who initially deny any agreement to repair the ditches along the Causeway/Vicarage Road. Money is no longer available on the electrify the railway budget, most of those previously employed have left and it is winding down. However they had agreed, under pressure, to cost the necessary repairs.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Cllr Fox Davies reported that Social workers were using new screening tools to pick up on vulnerable children targeted by drugs gangs. A rolling road had been set up for the OVO Energy Women's Tour professional cycling race on Wednesday 12 June. The route would go through Wallingford and end up at Blenheim Palace at about 2.15 pm.

County council announces major £3.5m highway improvement programme

More than more than 50 miles of road across Oxfordshire will be given a new lease of life thanks to the 'surface dressing' technique which waterproofs and extends the life of roads.

The cost of the work is in the region of £3.5m which is seen as a good investment, potentially preventing the need for more costly resurfacing for several years.

Oxfordshire County Council has taken delivery of a new fleet of electric cars and vans for its fire and rescue service and general staff pool car resource. As the largest council in Oxfordshire, the county council has already taken a strong lead and committed to being carbon neutral by 2030.

Funding has been secured from Public Health England for the development of alcohol services across Oxfordshire. A grant of £215,000 has been awarded, as part of £6m allocated to local authorities for 2019-20, to make it easier for people with alcohol problems to access help.

This funding will also support a homeless hub in Oxford city centre run by Oxford City Council, a family-focussed county-wide community project, and a homelessness hub run by the Salvation Army in Bicester.

He believed any development on this site including the building of a sports hall would incite the clause in the contract that a percentage of the value would be payable to him. He was meeting with his solicitor and Land Agent to clarify.
