A virtual meeting of Steventon Parish Council was held on Tuesday 5th January at 7pm

1. APOLOGIES FOR ABSENCE

No apologies had been received.

2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Rice, Mr M Stimpson-Tame and Mr M Tucker. Mrs A Einon (Parish Clerk) and Cllr Mike Fox-Davies (OCC), were in attendance. The meeting was joined by five members of the public.

4. PUBLIC PARTICIPATION

4.1. Lorries in High Street

Dr Wilding had distributed notices to the houses in High Street and Hanney Road asking for their experience of traffic problems to be emailed to Mike Fox-Davies. Twenty four responses had been sent explaining that the traffic had increased greatly, in both size and volume, particularly the HGV's whose night time speed and vibration affected residents many were frequenting the Steventon Storage facility. The traffic monitor would be installed in High Street as soon as the software was updated. Mike Fox-Davies had requested a meeting with an officer from Highways and the Parish Council to discuss the problems. Speed is felt to be perceptual individual, but data of actual speeds and times is required. Individuals along the routes have the ability to record on cctv and to calculate vibration. Mr Green suggested bringing together these people and try to come up with a consolidated report. To be organised in the next two weeks.

4.2. Emergency Services

The letter received by the Clerk, concerning the delay and failure to supply the defibrillator code, explained that the call was not considered a threat to life, category one, since the patient made the initial phone call.

Mr Green had contacted the lady in charge of ambulance liaison with Network Rail, who is now based in Slough, she is willing to join a zoom meeting with the other emergency services. Mr Green will re draft the letter to all the emergency services and get a zoom meeting together as soon as possible.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Cllr Mike Fox-Davies reported:

National Lockdown. Following the announcement by the PM on Monday evening, the UK is in Lockdown again.

Seven more local vaccination services, led by a GP-led Primary Care Network (PCN), will begin to deliver COVID-19 vaccinations next week.

Following a review of clinical evidence and the latest public health data, the JCVI and the Department of Health and Social Care have published updated guidance for the NHS on the dose interval for the second dose of the Pfizer BioNTech vaccine. It now recommends the second dose of the Pfizer BioNtech vaccine should now be scheduled for after three weeks but before 12 weeks after the first dose, and that the second dose no longer needs to be held in storage.

It is extremely encouraging to see the enthusiasm for the vaccine and to have a sense of an end being in sight. We need to support our NHS colleagues as they work hard to deliver this programme at the same time as managing the demands of COVID infections and winter pressures.

It will still take several months for the whole population to be vaccinated and we can continue to provide support by asking people to be patient and to reassure them that they will be invited for a vaccination as soon as possible.

Highways are still having to prove that the water running down Steventon Hill is sourced from Thames Water.

Mike Fox-Davies asked if there would be interest in David Johnstone or MP in joining our meeting next month.
