A virtual meeting of Steventon Parish Council was held on Tuesday 6th April 2021 at 7pm

1. APOLOGIES FOR ABSENCE

No apologies had been received.

2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Rice, Mr M Stimpson-Tame and Mr M Tucker. Mrs A Einon (Parish Clerk) and Cllr Mike Fox-Davies (OCC), were in attendance. The meeting was joined by six members of the public.

- 3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting. There were no declarations.
- 4. REPRESENTATIVES FROM THE ENVIRONMENT AGENCY WILL GIVE CLARIFICATION ON LANDOWNERS RESPONSIBILITIES AND ENFORCEMENT AND EXPAND ON FUNDING FROM DEFRA TO ALLEVIATE FLOODING FROM THE GINGE.

Shaun Shackleton and Evie Kingsmill attended the meeting and explained that in some instances a response had not been received from the Environment Agency when anything other than the emergency number had been used. The number to call for an emergency is 0800807060. The number is manned 24/7 and centrally monitored and actioned to a local level. Emails to individuals often are unanswered if the recipient is not in the office. The representatives are attending the meeting as a result of the Parish Council contacting them in a response to residents raising that flooding had increased in the Parish. Shaun told us that Defra provide annual funding to maintain the Ginge. Last year some maintenance may not have been done because of Covid. Applications had to be made to Defra for extra work that may be required such as bank repairs, bunds and blockages. Floods have occurred regularly onto the fields and work had not been prioritised as it did not affect properties. . Silt is no longer dredged from water courses as it has been found that it only rebuilds. The aim is to increase the flow so that it is washed out rather than physically removed. The current proposal is to reduce the height of the flow in the Ginge by 8 inches to a foot by removing a substantial blockage downstream. Permissions have been applied for which will allow the work to be done in the next six months. There is some overgrowth and vegetation in the channel this will be cleared in the maintenance programme. The biodiversity department do have to agree any proposals to ensure that wildlife and habitat is considered.

N Thompson asked if the culverts blocked with willow at the Stocks Lane could be prioritised. Shaun responded that dropping the water level would help these culverts, but the work is in hand to remove the willow as soon as the water level had dropped sufficiently to be able to access the water safely. The Parish Council thanked the Environment Agency representatives, Shaun and Evie for attending and for

a very helpful and useful exchange of information.

5. PUBLIC PARTICIPATION

5.1. HGV, potholes etc High Street

Update on visit to the village by Lee Turner from Robert Green. There is a proposal to spend £150 to put a tube survey across the road in the High Street. This measures the speed, number of axles and detect which is an HGV and which a car. From this we will know the timing, number, speed of all vehicles. It is hoped to coincide the tube survey with the person in the High Street who is able to record vibration. Lee

did say that the High Street is the alternative route to the A34 and therefore no restrictions to traffic can be applied. The potholes have been reported and promised an imminent repair also to replace flashing 30 mph indicator.

If the humps could be levelled in the High Street together with pothole repair would make the traffic less noisy. Mike Fox-Davies would follow up on the schedules for this work. He would like to establish a Traffic Advisory Group which would be a more rounded look than the A417 group that used to meet.

5.2. Milton Park

Roads in Milton Park have pedestrian crossings, 20 mph limits and many other benefits which we seem unable to get for residential areas.

Symptom-free testing at home and community collect for parents and carers

The government is encouraging all households with nursery, primary and secondary school and college-aged children and young people, including childcare and support bubbles, to take part in twice-weekly rapid lateral flow testing. This is mainly through a community collect scheme using home test kits.

Adults in one of these households who do not qualify for our symptom-free testing programme, can now collect home testing kits (each contains seven lateral flow device (LFD) tests) from any local testing site across Oxfordshire. **Schools Return**

Last month saw schools welcome back all pupils. We are not yet able to see how this first step in the easing of lockdown affects our COVID-19 cases, but the good news is that new cases are down across the county. We have also seen a continued decline in new cases in the over 60s, which is resulting in far fewer hospital admissions.

Large majority of Oxfordshire parents and children offered first school choice

Parents and children across the county have been offered their first choice of secondary school for 2021/22 in the vast majority of cases.

Target for cutting greenhouse gas emissions exceeded

Oxfordshire's aim of becoming a zero-carbon county by 2050 has received a boost with news that our target for reducing greenhouse gas emissions was exceeded last year.

Topping the table for recycling and composting

Residents in Oxfordshire have helped the county top the table nationally when it comes to recycling and composting for the seventh year in a row.

Important information for visitors to our household waste and recycling centres

The Easter holiday is one of the busiest times for Oxfordshire's household waste and recycling centres (HWRCs). We are asking people to defer their visits until after Easter if they possibly can to avoid getting stuck in gueues.
