# A virtual meeting of Steventon Parish Council was held on Tuesday 6<sup>th</sup> March 2021 at 7pm

#### 1. APOLOGIES FOR ABSENCE

Apologies had been received from Mrs C Denton and Mr M Tucker.

#### 2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs C Brickwood, Mr J Clark, Mr R Green, Mr J Rice, and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) and Cllr Mike Fox-Davies (OCC), were in attendance. The meeting was joined by six members of the public.

#### 3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

There were no declarations.

#### 4. PUBLIC PARTICIPATION

#### 4.1. HGV, potholes etc High Street

Thanks to Mike Fox-Davies for arranging for a meeting to be held between OCC traffic officer, residents, and Parish Council, to discuss the resurfacing and pothole repairs to improve the vibration problems. Funding had been received from the Councillor fund to improve the visibility of the zebra crossing we had submitted to Highways that flashing beacons and speed display signs; however, we are not allowed to put flashing beacons, these can only be used in the vicinity of a school. We are still pursuing the speed display signs see 7.2 and 9.5.3 below.

The current work on Steventon Hill to divert water will mean that a considerable area of the road will be require resurfacing. A look at the whole area including the bridge is required.

The traffic monitor results had been rejected by Highways when we discussed the zebra in Hanney Road. A meeting to be arranged between OCC and Robert Green as Parish representative to make clear what is required regarding monitor results, vibration results and CCTV. Mike Fox Davies would attend. A meeting to include residents would be arranged soon after to keep everyone informed.

#### 4.2. Emergency services at crossing

Mr Stork said that he had no response to his letter. Mr Green had been in touch with Lindsey, who was trying to establish who the National Incident Liaison Officer(NYLO) for our area, had put in an official request for information from Network Rail. Toby Elliott Network Rail had asked that an official request was not followed up but he would respond tomorrow. The NYLO is pivotable to organizing a meeting between all the emergency services to establish the protocol for all responding to emergency calls on the south side of the railway.

#### 4.3. Dogs off lead

Untrained dogs off lead have been causing problems to farmers, sheep have been worried, and a chicken killed. Farmers can shoot dogs that are interfering with their animals. Footpaths, because of their increased use and mud, have been widened by people walking alongside the designated path, are trespassing and damaging crops.

All incidents should be reported to the Vale.

The advice received from Vale Environmental Enforcement Officer re dog fouling

"Dog fouling is always a difficult crime to detect, so any help with photos/videos taken in any public places by any witnesses would be reviewed & assessed for quality of evidence and would need to be supported by a witness statement.

Please note, the person taking the photo/video needs to be aware of their own personal safety, as it may provoke a confrontation and is best to be taken discreetly if possible."

#### 4.4. OCC and Reservoir

Mr Stork reported that a group called Water Resources South East, composed of six water companies including Thames Water, seem to be taking the lead on submission regarding the reservoir. Mr Stork had written to OCC, Vale, Mr Richard Webber, and Mike Fox-Davies in the past asking that they be represented at these webinars, but no response had been received. The Vale had attended the webinar and GARD were meeting with the Vale on zoom to exchange ideas. Representation was required as we are likely to receive a fait accompli in July and not get a public enquiry. Mike Fox-Davies had sent the information to the Officers and would chase up attendees. Perhaps David Johnston could ensure that an independent review is essential rather than a peer group decision. Consultation document is very biased towards the water companies preferred outcome.

#### 5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

#### Oxfordshire update

For the week ending 19 February, there were 531 new confirmed cases in Oxfordshire, compared with 561 the previous week, a reduction of five per cent.

#### Vaccination update

Excellent progress continues to be made on delivering the COVID-19 vaccination programme across the county. Over 150,000 people in Oxfordshire have now received their first dose of the vaccine, including more than 95 per cent of people aged 75 and over, and over 90 per cent of those aged 70 to 74.

## Expansion of symptom-free testing to public-facing workers and volunteers

Oxfordshire's symptom-free testing programme will shortly be expanded to cover public-facing workers and volunteers across the county, including all frontline council staff. From Tuesday 23 February, free rapid testing will be available to anyone without COVID-19 symptoms who needs to leave home to work or volunteer and who does not have access to workplace testing through their employer.

Around one in three people with COVID-19 have no symptoms and so regular testing of public-facing workers will help us to stop the spread of the virus. It will help to identify and self-isolate those who are unaware they are carrying the virus, which will protect colleagues, customers and communities alike. The rapid spread of the highly infectious new variant of COVID-19 makes testing for those who work outside the home an even greater priority.

#### **Flooding information**

Rain and snowfall have led to higher river levels than normal in Oxfordshire over a prolonged period of time this winter. The Oxfordshire flooding toolkit gives advice to residents, business and landowners on how to prepare and respond to flooding.

#### Government commits to supercharge the Oxford-Cambridge Arc

The government has this week announced an ambitious plan to transform the Oxford-Cambridge Arc into the UK's fastest-growing economic region. The Arc is a globally significant area between Oxford, Milton Keynes and Cambridge, made up of the five counties of Oxfordshire, Bedfordshire, Buckinghamshire, Northamptonshire and Cambridgeshire. It supports over two million jobs, adds over £110 billion to the economy every year, and houses one of the fastest-growing economies in England.

The Chair thanked Mike Fox-Davies for his work to get the water problem on Steventon Hill sorted. He responded that he has been very frustrated by the number of emails he had sent over many months saying that when it froze there would be accidents. Nothing had happened until accidents had happened and although they have dug up the road water is still running across the road and down the hill.

The work from the last extensive inspection had just been completed. A view of the trees to be made when the spring growth highlighted any dead or damaged areas. The work by Arbor had been very efficient and had managed to cause no damage to the greens which was excellent considering the amount of water lying.

8.2. Annual inspection by the Council of unadopted roads, footpaths and waterways. Footpaths had been inspected recently. Any councillors to report any problems that they notice. Unadopted roads include those estate roads yet to be adopted. However they should come under the developers or maintenance company and not a Parish responsibility.

Met on February 11<sup>th</sup> to discuss the **Planning application** P21/V0140/FUL Workshop And Premises 2A 2-6 High Street Steventon Abingdon OX13 6RS Redevelopment of previously developed land involving change of use from Class E to Class C3, demolition of light industrial buildings (No 2A) and erection of replacement apartment building providing 7 no. apartments with undercroft parking and cycle storage, part-demolition of buildings (Nos 6 and 6A) fronting High Street to facilitate provision of parking and bin and cycle storage, with retained floor area consolidated for commercial use Class E.

P19/V2459/O Land behind 31 - 33 The Causeway Steventon OX13 6SE

Outline application for provision of Self-Build and/or Custom Housebuilding plots for 7 detached dwellings, with all matters reserved except for access and layout (amplified by Flood Risk Assessment received 4th November 2019; Highways Information received 19th November 2019; Biodiversity Impact Calculations received 11th February 2020 and Heritage Information; Self-Build information received 18th February 2020; applicants counsel advice received 20 March 2020; Self-build information received 8 April 2020; Heritage Information received 16 April 2020; and refuse vehicle tracking received 27 May 2020).

Joe McDermott and Andre Botha of Albright Dene joined the zoom and expanded on the plans. A number of items were raised and discussed, and the Parish Council decided to object the 2-6 High Street application and the submit further evidence to the appeal.

The right of way for pedestrians was raised by residents. The Clerk had received the forms required to be completed to adopt as a right of way. The major requirements are for evidence from residents that the footway had been used continuously for the past 20 years. Forms had been distributed to those that had raised the problem and were available from the Clerk if anyone would like some. Dr Wilding would speak to Glyn Davies. Mrs Denton had taken ten copies to distribute.

Mrs Brickwood, Martin Stimpson-Tame would set up a working party to liaise with Mr Habemehl and invite Sarinc and Alex Freeman, to make suggestions on the way forward on how to green up the village. The grass cutting contract required the appointment of a contractor. The Clerk had circulated local parishes to ask who they were using. The Clerk would provide the map of verges for the cutting contract.

The Clerk and Dr Wilding had met with Arbor at the hedge and he had suggested that although it was too late to do a lot of work before the nesting season, it would be possible to cut through the ivy at the bottom it would then die over the summer and be removed in August.
