# A virtual meeting of Steventon Parish Council was held on Tuesday 4th May 2021 at 7pm

## 1. ELECTION OF CHAIR AND VICE CHAIR OF THE PARISH COUNCIL TO STAND FOR ONE YEAR

Dr Christopher Wilding was unanimously elected to as Chair for a further year. Mr Robert Green was elected as Vice-Chair.

#### 2. APOLOGIES FOR ABSENCE

No apologies had been received.

#### 3. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mr J Clark, Mrs C Denton, Mr R Green, Mr J Rice, Mr M Stimpson-Tame and Mr M Tucker. Mrs A Einon (Parish Clerk) and Cllr Mike Fox-Davies (OCC), were in attendance. The meeting was joined by six members of the public.

#### 4. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

#### 5. PUBLIC PARTICIPATION

## 5.1. HGV, potholes etc High Street

We have agreed a price and placed an order for a simultaneous tube survey on the High Street and the Hanney Road. So far a date as not been received but hope that it will be possible for Richard Biddlestone to record the vibrations at the same time. Mr Green would contact Reverend Biddlestone to establish the possibilities.

The railway bridge sign has yet to be repaired and the potholes filled.

## 5.2. Planning Little Orchard

Objection from residents. The pinch point for traffic is dangerous the turning of more cars so close to the level crossing, and damage to be caused to the Grade II\* listed Causeway. The previous development of number 95 caused ditches and the Causeway to be damaged and a lot of problems for residents. This is in a conservation area where houses line the street with minimum development behind. The proposed area is also within the flood zone. Property would be overlooked both in the front and back gardens of an existing property.

#### 5.3. Reservoir

Gard had met with Councillor Yvonne Constance who is the current cabinet member on the environment and impressed on her the importance for councils to input to the water resources south east. Stakeholders in other areas include major councils. Gard will be trying to get together local councils into the water resources southeast plan, east invovles councils at an earlier stage and we are hoping to get a similar system. Results of local elections will be changing the mix of representation. Our local

candidates have expressed support in rejecting the reservoir.

## 5.4. Footpath on Steventon Hill

The path has been greatly reduced by bank slippage. Originally we were going to use the Councillor grant money but we were assured that Highways would cover this. The job is on the list to be done.

#### 5.5. Water on the hill

Mike Fox-Davies responded that the delay had been caused by a concrete covered conduit which required the electricity to be turned off before it could be dug up. Further emails had been sent including copying in David Johnstone. It is on the list of things to be done.

#### Support for children in need during half term

Schools and early years settings across Oxfordshire will once again receive additional funding from the county council to cover the costs of free school meal equivalent support over the upcoming half-term holiday, thanks to the extension to the national COVID winter support grant

### Frontline mental health professional is the face of a new recruitment campaign

We are encouraging residents who are looking for a challenging but rewarding career to train as approved mental health professionals, inspired by Oxfordshire practitioner Sijo Mathew

## Catering team 'steps up to the plate'

School children in Oxfordshire have eaten over half a million meals, prepared by Oxfordshire County Council's Catering Services (OCCCS) during the pandemic. The 150-strong team has introduced a range of healthy menus, adapting its service and also delivering over 1,000 free school meal food parcels during the last year. In 2018, the service was returned to an in-house operation following the collapse of Carillion. The service now operates in 60 schools, serving over a million meals a year.

## New food waste trial for parts of Oxfordshire

We are running a trial project to encourage more people to recycle their food waste, with information and food caddy liners being delivered to households from 10 May. The areas being targeted in the trial are parts of Oxford, Witney, Didcot and Harwell – almost 7,000 households in total. The deliveries are being made by council staff working alongside a cargo bike and rider provided by Oxford-based company Pedal & Post. Oxfordshire already achieves amongst the highest recycling rates in the country but despite this, around half of all food waste produced from Oxfordshire households is still disposed of into general waste bins.

#### **Harding Vale**

Issue raised clarify non consultation with residents or parish that the footpath has been removed. The Vistry technical manager had written and delivered to estate residents that outstanding items would be sorted out. No mention was made of removing the footpath. Arrange a meeting with the Vale, OCC to discuss what has happened. The original from the Vale stipulated that the footpath was part of the permission. No discharge of condition has been published.

Dr Wilding took this opportunity to thank Councillor Mike Fox-Davies for the work he had done on our behalf. Residents appreciated the input and help given by you over the time as our Councillor. We hope that your successor will be as involved.

## 14.1. Applications

14.1.1 P21/V0993/FUL Apple Cottage 4 The Green Steventon Abingdon OX13 6RP

Variation of condition 2 (Approved plans) in application P20/V0642/FUL. Construction of detached house and garage.

14.1.2 P21/V0703/DIS 6 Station Yard Steventon Abingdon Oxfordshire OX13 6RX

Discharge of condition 3 (Sign to be displayed prior to first use) on planning application P20/V2951/FUL (Proposed change of use of unit from Use Class E(g) (formerly Class B1) to an MOT test centre, a sui generis use.)

14.1.3 P21/V0825/HH 17 Joyce Way Steventon Abingdon OX13 6GA

Proposed ground and first floor rear extension

No objection.

14.1.4 P21/V0814/FUL Little Lane Orchard 95 The Causeway Steventon Abingdon OX13 6SJ

New detached four bedroom house and double carport.

The plans seem to indicate a five bedroom house.

Objection return to the vale:

This application is to build an additional house on the paddock land and orchard between 95 and the railway line. The permission to build 95 The Causeway P14/V2187/FUL stressed the acoustic effects of the railway line on the building and the area now proposed as a building plot. Comment from the decision notice: This should ensure that the overall size of the curtilage is appropriate, with the remainder of the site left as a landscape area. When 95 was permitted there was no local plan and therefore insufficient strategic housing allocation it also replaced redundant buildings. It is an important open space within the village which significantly contributes to the rural character and appearance of the area

When 95 was built there was major disruption in the area as contractors did not confine themselves to site and the road and particularly ditches in the vicinity were blocked and damaged. The Grade II\* listed causeway was also damaged by contractor lorries getting to the site via the narrow access.

A building on this site will be detrimental to the conservation area and the Grade II\* listed causeway. Given the position and orientation of neighbouring properties the amenities of these dwellings will be harmed by the proposal in terms of overshadowing, dominance or overlooking, particularly to number 97 The Causeway. The proposed four-five bedroomed property is too large and too close to the neighbours.

The access to the site is extremely difficult, narrower than when 95 was permitted as the railway crossing has changed in the area it occupies. Pedestrians particularly are in grave danger of impact as there is no designated area for waiting for the level crossing to open. People are standing in the accessway and when the gates open cars speed into this area or try to drive out across the traffic flow. A desktop survey does not show the complexity of the access nor the appropriate sweeps required for safe access and egress from this site.

Bins to be presented at the Causeway end of the driveway would cause further obstruction and danger to both drivers and pedestrians.

The area is within the flood zones 1,2 and 3. The NPPF (paragraphs 100-103) states that development should be directed away from areas at risk of flooding.

It is an open space providing a green area that will become overdeveloped by the addition of a further property.

14.1.5 P21/V1045/HH 9 Pugsden Lane Steventon Abingdon OX13 6RY Loft conversion No objection

14.1.6 P21/V1143/FUL The Old Farmhouse 5 Kennel Lane Steventon Abingdon OX13 6SB. Construction of a 50m x 20m all-weather outdoor riding arena.

No objection

14.1.7 P21/V1074/DIS 71 The Causeway Steventon Abingdon Oxfordshire OX13 6SQ Discharge of condition 3 (Materials) on planning application P20/V2800/HH & P20/V2801/LB. (Single storey extension to the rear to enlarge existing kitchen/breakfast area to modern standards. Partial rebuild of existing extension to improve structure and insulation, replacement of rear elevation ground floor windows. Minor internal works not affecting historic structure.)

## 14.2 Appeal on Land behind the Causeway

Dr Wilding and the Clerk attended the Team meeting. The Appellant's solicitor was very efficient, but the Heritage lady considered the Causeway to be disappointing and felt that the Inspector would not be impressed with the village. They apologised that Joe McDermott was not in attendance because he was in a meeting with a local resident to negotiate the purchase of a strip of land to widen the access at lunchtime it was announced that the strip had been purchased. The Vale commented that this was not relevant to the current appeal. The general discussion was about planning numbers and self-build provision. The feeling that the result will be the opinion of the Planning Inspector at the end of the day.

## 14. MATTERS FOR FUTURE DISCUSSION AND INFORMATION

Trees outside conservation area have no TPO's. Perhaps some may deserve protection from removal by developers.
