A meeting of Steventon Parish Council was held in the Millennium Room of the Village Hall on Tuesday 2nd November 2021 at 7pm

1. APOLOGIES FOR ABSENCE

Apologies had been received from Mr J Bennett, and Mr M Stimpson-Tame.

2. PRESENT

Dr C Wilding, Chair, Mrs S Broadbent, Mr J Clark, Mrs C Denton, Mr R Green, and Mr J Rice Mrs A Einon (Parish Clerk), Cllr Sally Povolotsky (OCC), and Cllr M Barber(VWH), were in attendance. The meeting was joined by ten members of the public.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

Mr Clark, Mr Rice and Mr Green declared an interest in the planning application for 57 The Causeway and left the meeting for this item.

4. PUBLIC PARTICIPATION

Trees at Field Gardens

The trees by the car parking on Field Gardens giving concern as they have grown very tall and would cause considerable damage if blown down. Ownership was unknown but some enquiries would be made.

Car in High Street layby

The car that appears to have been dumped in the layby opposite the coop since last July has been .reported to the Vale, however as it has current tax and MOT it is not illegal.

Level crossings emergency Sunday 31st October

On Sunday at about 4 pm at Stocks Lane the lights on the level crossing were flashing and the gates open this continued for some ten minutes. There had been problems all weekend and workmen at the Causeway crossing had waved cars across. Robert Green agreed to communicate with the crossings manager at Network Rail and arrange a virtual meeting.

Traffic volume

Detailed analysis of the tube recording was still awaited as the OCC analysis person has been off with Covid. The posts for the speed monitors had been installed and it was hoped that the monitors would be in place in the next few weeks. A motion by OCC to install 20 mph speed zones had been supported by the Parish Council and an application, supported by Sally Povolotsky, had been submitted for Steventon. Also, to push for Steventon Hill to be reduced from 60 mph to 40mph and when data on HGV's is clear to apply for restrictions on night-time movements in the village.

Land behind the School

Mrs Rees suggested that the land could be used for a community orchard and would be willing to research this in more detail if the suggestion was taken up. Referred to the S106 Sports hall working group. **Fireworks**

Please be responsible in your use of fireworks and notify immediate neighbours with children and pets who may well be upset by the noise. Remember their effect on wildlife and farm animals.

Planning application 57 The Causeway

Tristan Judge expanded on some of the comments he had received on the application. The garage would not be used for commercial purposes, totally private and personal classic car storage. The building was

not 7.5 metres high but 5.4 metres. There would be no traffic increase in the Causeway. No trees would be felled. Flood zone does not feature in the area proposed.

The garages have been reduced from 5 to 4 and the building size by 13% from 116 m2 to 100 m2. the hardstanding has also been reduced in size.

Village identity

The Steventon sign on the access to the village from Drayton has gone missing. The Clerk will report to OCC.

It was suggested that new access signs be commissioned to include the Steventon logo, this is part of the S106 funds available to the village as Art. We have commissioned a map of the village, which will be installed in the village hall car park, an artist has been appointed to design benches to reflect the areas they are located and possibly include a logo.

Drayton has some large walnuts installed on their green and it was suggested that perhaps something similar, horse chestnuts, could be put in the places where trees on the green have had to be felled. **Steventon History display**

Congratulations to Dick Bosley and his team for the brilliant history exhibition staged in the village hall, he is hoping to start a history group and there is to be an inaugural meeting at the North Star.

GARD

Derek Stork reported that GARD had moved quickly when Thames Water put out a redacted impact statement, many people had complained to RAPID. We thank everyone. Thames Water released an unredacted version of reports and we have until 19th November to respond. Our consultant is examining the reports to find the worst scenario.

5. .REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE Councillor Matthew Barber reported:

Garden waste collections had been restarted but it is possible that some may be late as there is a shortage of drivers.

Afghan refugees. Three families were being accommodated and donations are being accepted. Planning application from Gladman for 80 houses in the Abingdon Road is expected to go to Committee but not yet confirmed.

HGV movements. I am in touch with the Vale and support but there are limited powers.

Oxfordshire Plan 2050 and the joint Vale and South Oxon local plans are progressing.

Trees: climate emergency policy to plant trees on council land.

Parking enforcement will initially check on double lines etc and issue warnings, penalty notices will not be issued until the New Year.

The new Vale lottery is supporting charities and encouraging everyone to participate.

Councillor Sally Povolotsky reported:

OCC news:

New 20mph policy approved: OCC has finally launched its much-anticipated new 20mph policy. The policy has been widely welcomed by campaign groups, parishes, and residents. A website has been launched with more information on how the policy will work.

Bid for government funding for buses:

The county will bring forward an ambitious new plan to improve buses in Oxfordshire. The plan includes proposals for South and Vale, funding for these services will be dependent on the bid for £56 million from the government being successful.

New Local and Transport Connectivity Plan:

A new plan was approved at cabinet to promote cycling, walking and low-carbon transport in the county. It sets a goal of replacing one in every three car trips by 2040. Nestled within the plan is a new freight strategy that includes proposals for reducing inappropriate movements of HGVs through villages. The next step for the plan is to hold a public consultation, with final adoption scheduled for spring 2022.

Rough sleeping plan:

A new homelessness prevention strategy was approved by Cabinet. The strategy involves rapid response

when someone becomes at risk, and a focus on individual needs and circumstances to provide greater levels of support

Warning on social care funding:

Cllr Calum Miller, cabinet member for finance has issued a warning that unless the chancellor provides more money for adult social care and special educational needs councils will have no choice but to raise council tax so that we can continue to provide the care needed for vulnerable residents.

Civil parking enforcement: OCC enforcement of on-street parking offences comes into play this month, from 1st November. Dangerous parking is still a police matter.

The **Esso planning application** will go to Committee on 26th January.

GARD and the Motion to Full Council - this is on as an emergency item and will be read at the start of the FC as follows;

Motion by Councillor Richard Webber

"As information in the latest consultation remains incomplete, and what has been provided to support the proposal contains many errors, Council now confirms its position on the TW proposed Reservoir agreed at the Council meeting on the 10 July 2018 in that it remains opposed to the proposal, at least until the case for need has been clearly demonstrated by taking into account and answering the concerns of the whole scientific community."

Steventon items: 5 Current Cases

Received several contacts through social media, issues around Anti-Social Behaviour, Parking and Illegal Parking, Drugs Offences, Driving and Speeding. Signposted residents to Police, Parish Council and District Councillor where appropriate.

Talking to residents about Air Quality Survey starting after bridge survey

Bridge Survey Part 1 has commenced, managed to change access to allow pedestrians and cyclists.

Mr Clark and Mr Stimpson-Tame had assessed the trees around the greens and produced a visual report which had been circulated. There were several trees that had dead branches which they felt required a professional's attention and it was agreed to ask Arbor tree specialists to inspect and recommend further action. The ivy growth would be curtailed in house.

9.4.5 Watercourses

Mr Clark, Mr Stimpson-Tame with the help of Mr Atkey had cleared the ditches around the big green. The area by the school is getting blocked by overgrowth of iris and they plan to clear that area next with ongoing monitoring of leaves in the ditches. Dr Wilding thanked them for the considerable amount of time they had spent on behalf of the Parish Council and the villagers.

9.10.1 Milton Park Forum. CW, JR

A meeting would be held on 7th October gave a presentation of Milton Park plan to 2040. Between now and 2040 they intend to erect a further 14 buildings with the potential to link with the local plan, creating 10,000 new jobs on the site. Veronica Reynolds, Sustainability and Community Manager, explained that a compulsory purchase was ongoing to upgrade to a cycle track the link between Pugsden Lane and the underpass at Milton under the A34 the route being slightly different from the current footpath by the railway. The aspiration is to extend the cycleway to Grove alongside the railway line. The community fund which is contributed to by all the businesses on Milton Park had been 90% allocated to charities within the area. Newsletter available from the website.
