A meeting of Steventon Parish Council was held in the Millennium Room of the Village Hall on Tuesday 1st March 2022 at 7pm

1. APOLOGIES FOR ABSENCE

Apologies had been received from Mrs Pajak and Cllr Sally Povolotsky(OCC).

2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Mr J Clark, Mrs C Denton, Mr M Stimpson-Tame, and Mr J Rice. Mrs A Einon (Parish Clerk) was in attendance. The meeting was joined by eight members of the public.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting. Mr Rice had an interest in the Planning item for 57 The Causeway.

4. PUBLIC PARTICIPATION

4.1. Bridge

One way system now upgraded with proper guides and provision for cyclists going up the hill. The boreholes drilled at the edges are showing signs of movement. An initial short inspection appeared better than anticipated but it will be a minimum of one year with the one way system.

4.2 Link Road

Proposed road via Didcot and Appleford with a viaduct and bridge over the Thames to provide a new route must be completed by 2026 from the infrastructure budget or the Government funding will be lost.

43 Trees

Responsibility for falling trees and branches was raised. The owner of the land on which the trees are grown are responsible for clearing and maintaining.

- 4.4 **Gleeson** proposed development. The website and circulated information had said that Thames Water had done extensive modelling on the proposed reservoir. Thames Water have confirmed that no modelling has yet been done.
- 4.5 **GARD** had achieved 40 50 attendants at their meetings concerning the proposed reservoir.
- 4.6 **Thames Water** are holding an open meeting tomorrow in the village hall from 1.30 to 5.00 then moving to the school hall from 7pm to 9 pm. The BBC are proposing to attend at about 1.30. Suggestions for questions to raise include. Population figures are a lot higher than the recently released forecasts. Still no in depth investigations done. No experience of the type of installation proposed only one similar reservoir in Europe that has had a lot of problems.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE Councillor Sally Povolotsky reported by email:

Upmost apologies I cannot be with you, I am on a urgent members call around the HIF1 project. Meanwhile a bit of an update

- 1. Highways pavement issues are in work plan, chasing for completion dates on the two identified areas. Things are a little slow and still disrupted post Eunice and Franklin
- 2. Reservoir wrote to WRSE about digital exclusion concerns as a online only consultation as well as had more meetings than I can remember since we met last and supported the public meetings
- 3. Apology I didn't make Friday's meeting but was on a LGA training weekend
- 4. The Bridge next survey in March and final reports expected in April.
- 5. Over development am writing to VOWH and Highway's teams about concern over speculative and planning applications locally on all levels but especially given the unknowns on the "megavoir"
- 6. Thames Water consultation I will be there at both sessions tomorrow

No flagged matters arising.

The Annual meeting with the Parish was discussed. It was agreed that the meeting should be separate from the Annual Parish Council Meeting and a date in April would be investigated.

Applications

Discharge of condition 2 (Impact on Heritage Assets) on planning application P19/V2459/O. (Outline application for provision of Self-Build and/or Custom Housebuilding plots for 7 detached dwellings, with all matters reserved except for access and layout)

8.1.2 P21/V3550/DIS 57 The Causeway Steventon Abingdon OX13 6SE

Discharge of conditions 3(Materials), 4(Landscaping Scheme (trees and shrubs only), 5 (Tree Protection) & 6 (Submission of Details) on planning application P21/V2326/HH. (Removal of existing garage and construction of new garage block)

9. THE PARISH COUNCIL AS AN EMPLOYER

A circular from OALC reminding Councillors of their obligations as employers was discussed. It was agreed that although the Parish is complying with legislation regarding pensions etc they should be more involved in the running. The current Clerk had not wanted to enter the pension requirement by Government and returns had been made to that effect. When a new Clerk takes over there will be commitment for pension contributions from the Parish. OALC are running a training webinar on basic employment and Dr Wilding had been booked to attend on 26th April. Mr Rice thought he would be available to attend as well.

10. CONSULTATION REQUIREMENT WITH MEMBERS OF PARISH COUNCIL BEFORE PUBLICATION OR RESPONSE

Mr Rice asked for clarification on clearance required before publication with reference to the recent social media regarding the copse. Dr Wilding responded that there had been time pressure for publication of Steventon News and he had included it in his report. He felt that the social media release had been a mistake and would not be repeated. The Parish Council had previously discussed and decided not to have a dedicated social media outlet, and this was further agreed. It was further agreed that it was not necessary to have agreement from all Councillors before discussions with the press. If responses were required from all, nothing would be answered, as it is rare to get even a 50% response to an email request to Councillors.

11. UNAUTHORISED USE OF PARISH COUNCIL PROPERTY – BIKE TRACK IN THE COPSE

Complaints from residents had resulted in Dr Wilding and Mr Clark inspecting the Copse where they found considerable disruption caused by a home made bike track. The track had been created with deep holes and jumps in areas of footpath which made it dangerous for normal use on foot. The track had been removed. The Parish Council is not averse to recreational bike use, as illustrated by the installation of two jumps near the Copse, after formal application and approval, but must consider the safety and responsibilities involved. The Copse is not felt to be the right place for such an installation, the Parish Council has little land at its disposal but would support an application for a bike track on land put forward with owner consent. The Copse is used by the Forest School and many residents of the village. The Fairy doors trail during lockdown had provided interest and an opportunity to participate, along with decorated trees in the village.

12. ITEMS FROM RISK ASSESSMENT ACTION SCHEDULE

12.1 Bi-annual inspection by Council Specialist Tree Working Group

The trees on the greens were to be worked on from next week, after obtaining permission from the Vale for modifications in the conservation area.

12.2 Annual inspection by the Council of unadopted roads, footpaths and waterways Mr Clark agreed to organise a survey of the footpaths on the definitive map prefix 366. Councillors were asked to report to the Clerk any problems they encountered on footpaths or waterways, or were informed of by residents.

13. WORKING GROUP, SUB-COMMITTEE AND REPRESENTATIVES ACTIVITIES

13.1 Finance and General Purposes Committee JB, JC, JR, CW, Clerk

13.2 Planning Committee JB, CD, MST, CW, Clerk.

Gleeson had circulated the village with details of their proposed application asking for feedback on their plan to erect 150 houses on a site to the west of the Linden development in the Hanney Road.

13.4 Recreation and Open Spaces – Trees, Greens, Waterways, Footpaths, Playground, Sports Hall. SB, JC. CD. JR. MST. CW

13.4.1 Sports Hall Funds (Alternative uses) CW, SB, JC, JR, MST

1. **Social Area**. The plan for the area behind the school is progressing. A detailed plan would be available to view and discuss soon. Alternative costings were required before an application could be made for the S106 funds from the Vale. A meeting had been arranged with the School Heads for 23rd March.

2. Village Hall

Waiting for quotes for extending the stage and springing the floor.

3. **Sports and Social Club** were investigating plans to upgrade facilities.

Quotes and plans were waited from Steventon Sports and Social Club to upgrade the facilities particularly for women and the disabled.

13.4.2 Trees

An action day had been successfully arranged on Saturday 12th February when ivy had been cut from the trees on the greens by Mr Clark, Mr Stimpson-Tame, Mr Atkey and the Clerk.

13.4.3 Greens

Large skid marks and holes are still at the rear of the green caused by escaping horses. Mrs Pajak was not at the meeting, so report deferred.

13.5 Village Infrastructure & Resilience - Railway, Roads, Drains JB, JR, CW.

13.5.1 Litter bins

Two bins had been installed. One remained to be sited. General discussion about locations and possible installations. All hinge on arranging a schedule for emptying. The Vale have had a list of proposals for years, but no funds and no action have resulted. The Parish will investigate possible alternatives.

13.6 Sarinc CD

Mrs Denton reported that the Trusteeship of Dawn Clements would expire before the next meeting but she was willing to stand for a further term. It was agreed that Mrs Clements should be a appointed for a further four year period. In future anyone wishing to apply or extend their Parish nominated Trusteeship should apply in writing at least two months before the due date. The Clerk would ask the Sarinc Clerk to keep her updated with terms of office and due dates.

13.7 Neighbourhood Plan. JC, CW, Clerk, and volunteers: Lorraine Atkins, Laura Bosley, Dick Bosley, Caroline Miller, Nick Thompson
