# A meeting of Steventon Parish Council was held in the Millennium Room of the Village Hall on Tuesday 5<sup>th</sup> April 2022 at 7pm

#### 1. APOLOGIES FOR ABSENCE

Apologies had been received from Mr J Bennett, Mrs C Denton and Mr J Rice

### 2. PRESENT

Dr C Wilding, Chair, Mrs S Broadbent, Mr J Clark, Mrs Pajak and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) and Cllr Sally Povolotsky(OCC) were in attendance. The meeting was joined by thirteen members of the public.

#### 4. PUBLIC PARTICIPATION

### 4.1. Speedwatch

Mr Philip Brew proposed a Steventon Community Speedwatch group like the one organised in Harwell. Volunteers go out with a radar gun in groups of three the data is then entered on the speedwatch database website, where it is analysed and reviewed. Offenders get a letter from the Police and repeat offenders get a visit. The set up will cost £450 for the radar gun and high vis jackets for the volunteers at £33 per person. Volunteers would be recruited via Steventon News and dependent on numbers, groups could be arranged for specific areas. Signs have to be erected at the edges of the village to indicate that it is a community speedwatch area. Volunteers have to do an online course but Harwell have agreed to train the first group. Philip Brew would organise for the first year.

### 4.2. Ginge

Water from the Ginge/moat is overflowing into Mill Street. Possibly due to a fallen tree or the sluices requiring attention. The Clerk would write to Sarinc to ask if the warden could look at the sluices.

### 4.3. Play Area Muga

One of the fencing panels is being held together with cable ties. Playground Solutions have been aske to quote for the repair and possibly replacement of whole fence as there are other areas of concern.

## 4.5. Refugees

Many households had applied to give accommodation to refugees from Ukraine with no response from government. Harwell has many empty houses that are now in private ownership that are said to be condemned. There are many empty houses across the country particularly where the military have closed or reduced the size of their bases. These could be housing refugees.

### 4.6. Choral Society

The choral society are singing in the Church at 7p.m. on Sunday to raise money for the Ukraine free admittance all welcome.

### 5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

On Wednesday we had a briefing to give a little more information on the government's <u>Homes for Ukraine scheme</u> that we are collectively supporting as part of a joint system-wide team across Oxfordshire. We received a slide deck outlining what officers know about the scheme, the process for how we will respond and the structure that has been put in place as part of our joint team. Since then, the government has published a <u>welcome pack for arriving refugees</u> to signpost people to the help that is available, including

advice about accessing universal credit and job support. Our joint county team will be supplementing this with local information as well as providing clear signposts to help and support online.

Our website <a href="www.oxfordshire.gov.uk/ukrainesupport">www.oxfordshire.gov.uk/ukrainesupport</a> is being used as the central host for this information, which is being worked on as we speak. <a href="Sponsor information">Sponsor information</a> will be published later today on this site and local information for Ukrainian guests will follow. The government has also published a set of frequently asked questions for sponsors and individuals applying to the scheme.

As previously mentioned, there is fantastic joint work underway. The county council's customer services team has started to make first contact phone calls to hosts to initiate the accommodation and safeguarding checks required and letters will begin to be distributed as part of this process outlining next steps for hosts and guests.

However, it is important to also recognise that as we activate our plans, our approach and processes will evolve and improve as we get more detailed information from government.

Spring water on the hill has been inspected two separate gully blockages are to blame for some of the water. Thames water are to inspect the second leak in the middle of the road. Byway 16 has cones and sandbags to indicate the water runoff. The Hanney Road has been patched and the major holes filled. A meeting with the Storage Depot has been scheduled regarding licencing and HGV's.
