### Steventon Annual Parish Council Meeting was held on Tuesday 3<sup>rd</sup> May 2022 at 7pm in the Millennium Room of the Village Hall

### 1. ELECTION OF CHAIR AND VICE CHAIR OF THE PARISH COUNCIL TO STAND FOR ONE YEAR

### 2. APOLOGIES FOR ABSENCE

No Apologies had been received.

### 3. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Mr J Clark, Mrs C Denton Mrs S Pajak, Mr J Rice and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) and Cllr Sally Povolotsky(OCC) were in attendance. The meeting was joined by thirteen members of the public.

### 5. PUBLIC PARTICIPATION

### 5.1. Speedwatch Group

The speedwatch article and request for volunteers had not appeared in Steventon News but already twelve people had signed up. Exactly what support and funding is available from OCC, the police etc is not yet clear. The Parish Council were willing to provide support with requirements.

### 5.2. Parking outside Coop

Cars and vans using the area to park and obstruct the path for buggies and invalid carriages. Dr Wilding agreed to speak to the Manager.

### 5.3. Speed monitors have moved

The monitor from Field Gardens and west end of Hanney Road had been moved. It was explained that the monitors could not be a permanent fixture but had to move around, their alternative locations were the east end of Hanney Road, by the allotment shed, and High Street, near the vet.

### 5.4. Zebra crossing Hanney Road

Cars and vans parked on the verges were obstructing the vision of people and drivers. Cllr Povolotsky had a contact in the housing association that she would provide to the Clerk who would then write expressing the problem.

We are continuing to work with our district colleagues to redefine our working relationship with
Cherwell. The Joint Shared Services and Personnel Committee, made up of elected councillors from both

the county and district councils, met on Monday 25 April and agreed the future arrangements for several service areas currently being delivered jointly. The following future arrangements were agreed:

Corporate health and safety: Joint working arrangements will end from 1 May, with postholders continuing to work for their respective employing council.

Policy and strategy: Joint working arrangements will end from 1 May, with postholders continuing to work for their respective employing council.

Joint management arrangements for the healthy place shaping team: These joint management arrangements will end from 1 May, to enable the district council to review its overall wellbeing offer. Healthy place shaping remains a core focus for us here at Oxfordshire and we will work with all of our city and district partners, as well as those in the NHS and voluntary and community sectors, to continue to make progress in this area.

Internal audit and anti-fraud: We will continue to provide internal audit and anti-fraud services to Cherwell, with a new agreement to be put in place.

Climate action: Formal joint roles will end, with postholders continuing to work for their respective employing council. We are developing a new agreement to continue to work together to share specialist advice and support. The intention is to develop a new agreement and implement the change by the end of May.

**Relief to Rowstock** - there was a good parish council engagement piece a few weeks ago, please do respond to any materials sent (especially Harwell and Steventon due to the initial location for the scheme). A public consultation will run in the next six to eight weeks. The proposal is for a dedicated bus lane and cycle provision.

**HEG Community Larder** - continues to be a success, and now there is a greater shift around now people using it for financial / food emergencies, which is sad indeed. However, we have a plan around expanding HEG to surrounding villages where there are concerns. We are starting this with Steventon, we have several users and volunteers who are willing to 'drop' boxes at peoples doors. Anyone can join the HEG larder from anywhere, people can join here - <a href="https://www.sofea.uk.com/purpose-projects/community-larder/">https://www.sofea.uk.com/purpose-projects/community-larder/</a>. We do have access to some limited discretionary memberships for anyone identified in real need.

HIF1 - Didcot Garden Town Housing Infrastructure Fund programme (hereon in referred to as HIF1\*). I am on the HIF1 working CAG around issues with HIF and plans for the future. I am fully supportive of achieving outcomes for Didcot and surrounding areas to alleviate pressure of traffic, HGV and more decarbonised and sustainable travel. There is a site visit early June, and more details coming soon. ### \* HIF1

- (a) A4130 widening from Milton Interchange to a new Science Bridge by making it a dual carriageway;
- (b) a new Didcot Science Bridge from the A4130 over the Great Western Railway Mainline into the Didcot 'A' Power Station site and re-joining the A4130 Northern Perimeter Road north of the Purchas Road/Hawksworth roundabout.
- (c) a new river crossing and link road between the A4130 at Didcot and A415 at Culham, including two new bridges.
- (d) a Clifton Hampden Bypass between the A415 at Culham Science Centre and B4015 north of Clifton Hampden.

The primary focus of HIF1 is to provide additional highway capacity and connectivity to resolve long-standing capacity constraints that is preventing new homes and jobs allocated in local plans from coming forward in a timely manner. Additionally, the infrastructure will include high quality and completely

segregated cycling and pedestrian facilities. Coupled with creating the right environment for enhanced bus services in the area, the new infrastructure will provide residents with real mode choice.

**20mph roll out**, we now know that Blewbury, Chilton, East Hendred and Steventon are in Traunch 1 of the scheme, more details coming soon. Steventon has a temporary 20mph over the bridge.

### **Steventon Bridge**

The April survey was scheduled while the line was not in use between 12.15 and 4.50 am. Network Rail staff have to be present and they arrived forty minutes before reopening of the line. The inspection revealed that the centre section appeared to be alright. A meeting has been scheduled for the third weekend in June when the way forward would be decided. The cracks on top are being monitored.

Stonebridge Road pavement is on a repair report for this week.

Milton Lane water leak reported to Thames Water.

### 9.1.1 P22/V0909/FUL Little Lane Orchard 95 The Causeway Steventon Abingdon OX13 6SJ

Self-build four bedroom detached house with double car port

Steventon Parish Council return on Planning application P22/V0909/FUL

Little Lane Orchard 95 The Causeway Steventon OX13 6SJ

Parish Council meeting 3rd May 2022 decision.

No objection to the proposed four bedroom house but would like the following to be seriously considered.

This application is to build an additional self-build house on the paddock land and orchard between 95 and the railway line. The permission to build 95 The Causeway P14/V2187/FUL stressed the acoustic effects of the railway line on the building and the area now proposed

as a building plot. Comment from the decision notice: This should ensure that the overall size of the curtilage is appropriate, with the remainder of the site left as a landscape area. When 95 was permitted there was no local plan and therefore insufficient strategic housing allocation it also replaced redundant buildings. It is an important open space within the village which significantly contributes to the rural character and appearance of the area

When 95 was built there was major disruption in the area as contractors did not confine themselves to site and the road and particularly ditches in the vicinity were blocked and damaged. The Grade II\* listed causeway was damaged by contractor lorries getting to the site via the narrow access and very tight turn from the level crossing.

A building on this site will affect the conservation area and the Grade II\* listed causeway. Given the position and orientation of neighbouring properties the amenities of these dwellings could be harmed by the proposal in terms of overshadowing, dominance or overlooking, particularly to number 97 The Causeway. The proposed four bedroomed property is large and close to the neighbours.

The access to the site is extremely difficult, narrower than when 95 was permitted as the railway crossing has changed in the area it occupies.

Pedestrians particularly are in grave danger of impact as there is no designated area for waiting for the level crossing to open. People are standing in the roadway and when the gates open cars speed into this area or try to drive out across the traffic flow.

Bins to be presented at the Causeway end of the driveway would cause further obstruction and danger to both drivers and pedestrians.

The area is within the flood zones 1,2 and 3. The NPPF (paragraphs 100-103) states that development should be directed away from areas at risk of flooding.

It is an open space providing a green area that will become developed by the addition of a further property.
