# Steventon Parish Council Meeting was held on Tuesday 4<sup>th</sup> October 2022 at 7pm in the Millennium Room of the Village Hall

#### 1. APOLOGIES FOR ABSENCE

Apologies had been received from Mr J Clark.

## 2. PRESENT

Dr C Wilding, Chair, Mr Bennett, Mrs S, Broadbent, Mrs C Denton, Mr J Rice and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk)and Cllr Sally Povolotsky(OCC & VWHDC) were in attendance. The meeting was joined by eight members of the public.

## 3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

No declarations were made.

## 4. PUBLIC PARTICIPATION

#### 4.1. Truck

Dr Wilding informed the meeting that he had written to Truck with copies to the Vale licencing officer concerning the problems with parking, litter, Castle Street, and the copse, emphasizing that not all was bad some things worked very well. The traffic plan had omitted the affects of buses offloading in the centre of the village. Truck have now organised a meeting at 7pm in the village hall next week, 11<sup>th</sup> October. The Vale were quick to respond and will pick up on the application next year.

# 4.2. Speed watch

The Clerk had discussed with Highways the location of signs to order. Agreement had been reached that the signs could be attached to the existing access to the village signs on Abingdon Road and Hanney Road, further investigations were required for Steventon hill as it was likely the sign could block visibility for an existing driveway. Highways had recommended landscape signs that could be fixed to existing locations.

Mr Brew reported that the group were now doing regular sessions 2 to 3 times per week, though restricted by daylight. The response from the village has been good.

# 4.3. Neighbourhood Plan

The plan required some further editing and tidying up but would then be sent to the Vale for their input before submitting for inspection, they have six weeks from that date to make comments, or say it was unfit for purpose, it would then go to referendum and be decided on a majority vote.

# 4.4. Foot path Stonebridge Road

The work to repair the footpath is scheduled to start next week though the corner is as far as it is going.

# 4.5. St Michaels play area

Two fencing panels around the MUGA closest to the school are now damaged. Playground Facilities had been asked to quote for repair or replacement, but nothing had been received.

## 5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Bridge update: Highways have finished patching one side. However, the stabilisation of the worst of the brickwork and further inspections indicate that the restrictions will be maintained long term. It is proposed to install more permanent guides. The closure in December to level out the hump may lead to a review of the priorities. The 20 mph throughout the village should be in by January.

Rowstock relief are starting the consultation on the changes at Steventon lights and would be holding a presentation in Steventon.

Reservoir: WRSE and Thames Water will be releasing their draft plans for the South-east region and the Thames Water area respectively on 14th November.

## 8.1. APPLICATIONS

#### 8.1.1 P22/V2111/HH 8 Mere Dyke Road Steventon OX13 6AX

New garage extension to side of house with bedroom above, new dormer window in attic and rear extension including remodelling of the existing extension and conservatory

No objection to the principal of extension but clarification on boundaries and vehicle parking required.

# 8.1.2 P22/V1312/FUL 1 School Close Steventon Abingdon OX13 6AZ

Proposed extension to accommodate a 2 bedroom dwelling on corner plot. (as amended by plan and agents email received 13 July 2022 and amended plans received 12 September 2022)

Return submitted by agreement prior to meeting. On the revised application. The proposed development, though reduced from a three to two bedroom, is still forming a terrace property which is not in keeping with any others in the whole of school close. It also devalues the neighbour's property by turning that into a terrace.

The reconfigured proposed parking which requires a dropped curb in Stonebridge Road is creating a hazard in an already dangerous location. The proposal requires vehicle movements to make use of both spaces as they are sited one behind the other. The location is on the bend between St Michaels Way, Stonebridge Road and School Close an area already having major traffic problems as the school is close by and School Close is the access to a major housing development. If awarded this will set a precedent for the other 2 properties in the same location to apply build further houses, in an already overpopulated vehicle area.

# 10.5. Recreation and Open Spaces – Trees, Greens, Waterways, Footpaths, Playground, Sports Hall. SB, JC, CD, JR, MST, CW

Recreation and Open Spaces had met on 13th September and adopted the terms of reference.

# 10.5.1. Sports Hall Funds (Alternative uses) CW, SB, JC, JR, MST

Dr Wilding had drafted the S106 application for an eco-park and passed to the Clerk for submission.

The case for the eco play area as part of the sports hall. In principle the whole project has to be of similar benefit. We have two quotes for the eco park which will benefit all ages with its sensory garden it is also educational and supported by the school. The Village Hall sprung floor also supports all ages. Changing room facilities at the Sports and Social club give facilities for female and disabled users. The application for S106 will fully fund the eco park, and part fund the floor and facilities.

#### 10.5.2. Play area

The meeting had discussed extensively the existing problems with Playground Facilities and had agreed that an alternative contractor was required. Quarterly inspections by a company able to carry out any work required. OPFA for recommendations and the School company who had quoted for the eco park. Since the meeting Mr Stimpson-Tame had spoken to the company who considered that it would cost between £2k and £2.5k to correct the faults in the Rospa report, and £150 per quarter for a report and likely £350 per visit for repairs at cost.

The tire and zip wire may be under manufacturer's warranty but nothing was forthcoming from Playground facilities.

#### 10.5.3. Signage at Copse

New signs were required at the entrances to the Copse specifying no horses etc and ownership of the Parish Council. Mr Rice agreed to draft the wording, size, and proposed location.
