# Steventon Parish Council Meeting was held on Tuesday 1<sup>st</sup> November 2022 at 7pm in the Millennium Room of the Village Hall

#### 1. APOLOGIES FOR ABSENCE

No apologies had been received.

#### 2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Mr J Clark, Mrs C Denton, Mr J Rice and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) and Cllr Sally Povolotsky(OCC & VWHDC) were in attendance. The meeting was joined by nine members of the public.

#### 3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

Mr Rice declared an interest in the Planning application for 57 The Causeway.

#### 4. PUBLIC PARTICIPATION

Dr Wilding thanked Steventon History Society for the brilliant poppy trail around the village they had done for the armistice.

#### 4.1. Near miss on zebra crossings

The dangers of crossing the road on our two zebra crossing was again raised. Near misses are frequent and will eventually result in a serious accident. There is no obvious solution to this problem, light controlled crossings would be ideal, but we do not qualify and the costs to install are in the region of £80-£100k each.

# 4.2. 20 mph Speed limit

It was hoped that this would be brought in by January, consultation about to start.

#### 4.3. Rowstock relief scheme

Out for consultation. 10 million pounds to install a dedicated bus lane to the A34 across Steventon lights. Stage 1 unlikely to progress to Stage 2 as no funds available.

#### 5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Oxfordshire County Council has to make savings of 50 million pounds. The proposed bridge from Milton Heights will not longer be on the plans. The footpath/cycle way to Milton Park is already in action under S106 which should be released by January. Each section has been asked to suggest areas to cut. An application had been made to install an ANPR camera near the Steventon lights.

Pursuing ownership of the verge on Hanne Road. Speed survey on the Hanney Road has given good data on HGV movements. The appeal on the Esso site the Vale has employed barristers to fight the case.

Thames Water have applied for a drought permit to draw down water to refill Farmoor due the water lost at Heyford Hill major water leak. Reservoir: WRSE and Thames Water will be releasing their draft plans for the Southeast region and the Thames Water area respectively on 14th November. The water summit is due on 30<sup>th</sup> November.
