# Steventon Parish Council Meeting was held on Tuesday 4<sup>th</sup> April 2023 at 7pm in the Millennium room of Steventon Village Hall

#### 1. APOLOGIES FOR ABSENCE

Apologies had been received from Mr J Rice.

#### 2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Mr J Clark, Mrs C Denton and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) and Cllr Sally Povolotsky (OCC & VWHDC) were in attendance. The meeting was joined by sixteen members of the public.

#### 3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

Dr Wilding declared an indirect interest in planning application P22/V2195/FUL 59 Hanney Road.

#### 4. PUBLIC PARTICIPATION

The May Parish Council meeting after the elections, would be held on 9th May in St Michael's School Hall, this is the first date that the new Parish Council are able to meet by law.

Dr Wilding reported back on items raised at the previous meeting:

#### Cycle track to Milton

Milton Park forum: Milton Park had been given the Local Development order and S106 for local infrastructure. They had agreed to push forward on the cycle path between Milton and Steventon which has been on the cards for over seven years. The time scale for delivery is not certain as some land issues currently and a need to compulsory purchase. OCC also have to agree that it will not be the full 3 meter width required, an alternative route is necessary at Steventon end as the current rising ground to the bridge will remain a footpath as it is unsuitable for a cycle way.

A brief presentation by Vanessa Clipstone from Laister to expand on the changes to be submitted to planning application for 2-6 High Street Steventon (P22/V1425/FUL).

### 4.1 Nets and Sports and Social Club

The cricket net installation had been completed. The Sports and Social Club has undertaken to maintain both visually and practically, the area of the green leased from the Parish Council specifically for this purpose. An extension to the patio at the Sports and Social Club was mentioned but the Parish Council had not received an information or requests for any changes.

#### 4.2 Water fall fence.

The area of bridge over the Mill stream had been fenced off. Apparently by OCC following a report on Fix my Street.

#### 4.3 Mill Street

The road and bank were in bad repair and suffering from water damage from the increased hight of the water in the ditch the sluice appeared to have been increased.

#### 4.4 Manor Farm change of use

Clarification on the parish council return on this planning application access was requested. The response had included that access to the building, if change of use were granted, must be via Church Lane not Vicarage Road.

Sally Povolotsky asked to be included in any problems so she can back up residents.

#### 5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

I have been hugely concerned and internally campaigning at the council for months, I also have a large casework bag of SEND issues in the division – as a result I have moved to Peoples Scrutiny and attended my first meeting this week, I asked for and proposed a short sprint task and finish group to get to the bottom of the awful numbers here - (Public Pack)Agenda Document for People Overview & Scrutiny Committee, 30/03/2023 10:00 (oxfordshire.gov.uk)

We know there are national pressures but there are some LA failures in my view and I am hoping that this group will get to the bottom of the poor statistics and residents experience.

Flooding issues post heavy rain, distributed the Flooding Toolkit where I could online for residents. Link is here Oxfordshire County Council – Flood Toolkit (oxfordshirefloodtoolkit.com). Thames Water informed us that the pumping station had failed many villages had been told the same about their pumping stations. The Ginge and Letcombe brook had sewage outfall before the rain cause for serious concern.

Promoting rural library services to get books delivered to homes.

Concerns from residents about Potholes, please keep reporting them on Fix My Street as normal.

Feedback from Fire and Rescue over PC concerns around the crossing times – they have assured me they have tested the track access and are happy with that. Noted the NR FOI by the PC.

I also posed a question to cabinet around Steventon Bridge and am chasing this up and posed a supplementary around timing and 'same old message'. I will continue to chase this. The road surface is making a difference.

CMS Highways for the 20mph is in forward plan for April and I will be representing again. Stonebridge Road on the schedule for June/July.
