Steventon Parish Council Meeting was held on Tuesday 4th July 2023 at 7pm in the Millennium room of the Village Hall.

1. APOLOGIES FOR ABSENCE

Apologies had been received from Cllr Povolotsky

2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Mr J Clark, Ms L Perkins, Mr J Rice, Mr R Wilkinson and Mr M Stimpson-Tame. Mrs A Einon (Parish Clerk) was in attendance. The meeting was joined by eight members of the public.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

Dr Wilding declared an interest in item 8.1.5.

4. PUBLIC PARTICIPATION

4.1. STONEBRIDGE ROAD PARKING

Commercial vehicles from Cotswold Vehicle Recovery, based in Carterton, were making it difficult for residents to get in and out of their property. On occasions there have been three recovery vehicles parked on the street. The Parish Council had written to the company but had no response. Dangerous and obstructive parking should be reported to the police on 101. The Vale of White Horse and Oxfordshire County Council are responsible for parking in the area.

4.2. BLOCKED DRAIN

Castle Street had a blocked drain resulting in a garage being flooded. Problems with drainage, potholes, lighting should be reported online at Fixmystreet.

4.3. 20 MILE PER HOUR LIMIT.

The new signage had now been installed and the limit activated.

4.4. DOG POO

Dog poo in the village is a big problem, irresponsible owners not picking up after their pets. The Parish Council are investigating the costs of a bag supply station in the hope it may improve the problem.

8. PLANNING MATTERS

8.1. Applications

8.1.1. P23/V1394/DIS 57 The Causeway Steventon Abingdon OX13 6SE

Discharge of condition 4(Windows) on application P22/V2340/LB. (Alterations and upgrades to existing windows and new openings formed as per the plans and statement).

8.1.2. P23/V1361/DIS Manor Farm Church Lane Steventon Abingdon OX13 6SN

Discharge of conditions 3(phased risk assessment) & 4(remediation strategy) on planning application P23/V0267/N4C Change of use from agricultural to flexible use including B8.

8.1.3 P23/V1427/HH 85 Hanney Road Steventon Abingdon OX13 6AN

Rear double storey extension, side dormer extensions, front porch and remodelling ground floor and loft floor.

Steventon Parish Council are concerned that the application is not a simple residential extension of a dwelling house. The number of bedrooms and layout seem to indicate a care home or house of multiple occupancy, both of which require detailed building regs etc. The current car movements and parking also indicate other than normal occupancy of a dwelling house. This was raised previously when a garden extension was given permission.

http://www.oasisprivatecare.co.uk/ indicates that care is provided elsewhere, but is this for staff accommodation etc.

There is no objection to the building work but as above serious concerns as to purpose.

8.1.4 P23/V0496/HH 81 Hanney Road Steventon Abingdon OX13 6AN

Erection of single storey rear; part single storey front; rear hip to gable loft conversion with two side dormers extension.

No objection to this application. Although it is extensive it does not exceed the current roof line. Dr Wilding left the meeting for the item 8.1.5.

8.1.5 P22/V2195/FUL 59 Hanney Road Steventon Abingdon Oxfordshire OX13 6AH Demolish existing 2 bed bungalow. Erect new 4 bed chalet style house (amended plans and additional flood risk information submitted 29 June 2023)

No objection to the proposed lower profile, though still had some concerns about overshadowing of neighbouring properties.

VWHDC Planning Committee to decide on the application for 2-6 High Street tomorrow, 5th July. The Parish council would be able to speak for 3 minutes, Dr Wilding agreed to attend the meeting and speak on behalf of the council as no other councillor was available.
