Steventon Parish Council Meeting was held on Tuesday 5th December 2023 at 7pm in the Millennium room of the Village Hall.

1. APOLOGIES FOR ABSENCE

Apologies had been received from Ms L Perkins, Mr J Rice, Mr M Stimpson-Tame and Cllr S Povolotsky (VWHDC & OCC).

2. PRESENT

Dr C Wilding, Chair, Mr J Bennett, Mrs S Broadbent, Ms L Cann, Mr J Clark, and Mr R Wilkinson. Mrs A Einon (Parish Clerk was in attendance. The meeting was joined by eight members of the public.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting. No declarations were made.

4. PUBLIC PARTICIPATION

Dr Wilding informed the meeting that Cllr Sally Povolotsky had resigned from the Liberal Democrat party. However she intends to continue representing the areas as an independent.

The Neighbourhood Plan consultation will launch on 7th December please lodge any comments it I accessible on the Vale of White Horse website or contact the Parish Clerk to view a printed copy.

S106 funding would see the installation of the bespoke spiral bench on the Green in April.

4.1. RELIEF OF ROWSTOCK

Carole Hooper of Rowstock Residents Association spoke about the proposed changes to Steventon Lights. If you go to the OCC website and search for Relief to Rowstock you find the update for the A4130 Steventon Lights integrated transport scheme).

It states:

The **aims** of the A4130 Steventon Lights integrated transport scheme are to:

- Facilitate improvement to public transport
- Provide suitable infrastructure to encourage the use of sustainable and active travel modes.
- Improve safety for all road users
- Reduce congestion and capacity issues and improve journey time reliability
- Facilitate planned growth in the area

At the public Consultation back in November 2022, the public were told the stated 'purpose of the scheme' were the above points. Anyone attending the consultation and looking at the web site would legitimately expect congestion for private vehicles to decrease. However, OCCs own Consultants told OCC nearly 2 years ago and 10 months before the Consultation that this was not the case.

OCC recently, at our request, held a meeting with RRA and the Parish Councils where we questioned them on their misleading of the public at the consultation and their response was "the consultation advised that the scheme will 'aim' to mitigate congestion at Steventon Lights. The consultation did not state that the scheme 'would' reduce congestion." So the purpose to reduce congestion, was an objective and now it's just an aim.

We fail to see the distinction between these words in the context of a consultation where, don't forget the public were told the purpose was to reduce congestion.

If £10m of public money is spent on our roads aims, objectives or any other synonym they use can reasonably be expected to lead to the suggested outcomes. Well they know it won't reduce congestion as their consultants told them this nearly 2 years ago. ALL THIS TO REDUCE BUS JOURNEY TIMES BY BETWEEN 8 AND 157 SECONDS.

At the meeting with OCC and the Parish Councils, OCC claimed they could mitigate some of the increased congestion by "tweaking" the traffic lights. In other words, reducing the number of pedestrian crossings per hour. This would impact the cyclists as this is how they are expected to cross this 5 lane junction. So, we now see it's a £10m white

elephant for the benefit of **buses only**. OCC have stated they are going to proceed with this ill thought out scheme in April 2024 with planned completion in May 2025.

RRA are asking for the support of Steventon PC in demanding the chosen design should be reviewed openly and transparently with the truth put before the public with a further public consultation conducted.

Steventon Parish Council do not support the scheme and have submitted comments to OCC. This was supposedly phase 1 of a scheme but no phase 2 or further aims have been outlined.

4.2. VILLAGE GREEN POLICY

Clarification on usage was required. The new policy states: "All instances of maintenance and repairs will be carried out by the Parish Council, or by contractors that the Parish Council appoints to carry out such works." The Sports and Social Club would continue to maintain the pitches as delegated by the Parish Council. The Greens were not available for commercial use unless it was of benefit to the residents. All applications should be made to the Parish Council for their consideration.

6. APPROVAL OF THE MINUTES OF THE LAST MEETING

The minutes of the meeting held on 7th November were accepted as a true record.

7. MATTERS ARISING FROM THE MINUTES OF THE PREVIOUS MEETING – REPORTS ON ACTIONS

7.1. S106 ART

The sheet of acrylic had been installed over the village map and a financial report returned to the Vale of White Horse District Council.

7.2. BIN VILLAGE HALL

A bin had been purchased for the new location near the village hall. A quote for its installation had been accepted and it was now in situ.

7.3. SEAT IN HIGH STREET BUS STOP

Measurements had been taken for the required seat and a quote for its installation received. Seat cost approximately £250 installation £280. It was agreed that orders should be placed for the work.

The condition of the bus shelter had raised concerns with the Clerk and Mr Clark while taking measurements for the seat. There is considerable wood rot, ivy growth and the roof leaks. The Clerk had asked Mr Brew to assess and quote for repair.

Survey by Mr Brew:

The shelter is of timber construction clad with waney edge boards on the sides and roof. In addition the roof boards sit on top of plyboard and roofing felt.

The roof boards are coming loose and have suffered a high degree of decay. There are signs of water damage on the inside indicating that the felt and plyboard are at the end of their useful life as well.

The boards on the sides are coming loose in places but are in much better condition. There is quite a bit of ivy growing over and under the boards.

Recommendations

- Strip off ivy
- Remove roof boards, felt and ply
- Renew ply with 11mm hardwood plyboard
- Cover plyboard with layer of roofing felt
- Replace roof boards with 19mm x 250mm waney edge larch boards
- Secure side boards

• Dispose of all waste

Total cost £870

The Parish Council agreed that an order should be placed with Mr Brew for the work.

8. PLANNING MATTERS

8.1. Applications

8.1.1 P23/V2502/FUL 15 The Causeway Steventon Abingdon OX13 6SE

Retrospective partial demolition of the existing dwelling and proposed complete demolition of the dwelling and its rebuilding including previously approved extensions.

Risk assessment required on neighbouring property before any further work. There is no mention in the application that the reason for demolition is that a considerable portion of the house fell down when previous agreed planning work was attempted. Nor that the neighbour has been evacuated and unable to obtain access to her property since. As no foundations is reputed to be the cause of collapse it would seem probable that demolition of part of the semidetached property would cause the remainder to be dangerously affected.

8.1.2 23/V2431/FUL Land at 23 High Street Steventon OX13 6RZT

Erection of detached single storey two bed dwellinghouse, with car parking, bin and cycle stores. Demolition of conservatory, single storey rear extension and outbuilding to existing house, addition of rooflights on northern roof slope elevation and blocking up of first floor window on western elevation.

No objection to the proposed new property by the Parish Council, but again concerns about the lack of foundations for listed building number 19.

9. FOOTBALL ACTIVITIES ON THE GREEN

The Parish Council had concerns about safeguarding and safety of children who were participating in half term and holiday activities on the Green. Where parents were not present and delegated responsibility to the organisers of group events. Martin Trower attended the meeting and explained that the academy was organised by Ashley Sims who is a member of the Football club and took training on Wednesday evenings. He used the Sports and Social Clubs equipment and facilities. Mr Sims would meet with the Parish Council. The Parish Council is keen to support football and cricket on the Green but not for it to take over the facility from other residents.

10. ITEMS FROM THE RISK ASSESSMENT ACTION REGISTER

10.1. Review Register of Council Owned Land annually

The list had been circulated. The Clerk explained that an application had been made to the Land Registry after the meeting in November 2022. She had chased up several times and had recently been told that the application should be processed by July 2024. The application would register the village greens and the areas behind the pumping station and Sheepwash Lane.

A very successful Ditching had been arranged by Mr Stimpson-Tame on the 18th November. The North Star had generously provided refreshments for the volunteers.

Mr Clark and Mr Bolton had trimmed the willow tree that was overhanging the bridleway.

Quotes had been received from Arbor Tree Specialists for removal of the willow on the village green that had shed a lot of its branches in a storm. £900 plus VAT. Permission had been obtained from the Vale of White Horse DC to fell a tree in the conservation area.

Quote also for severing the ivy and prune and trim both sides of the hedge in School Close car park that has become very overgrown and encroaches on the neighbour, cark park and pathway. £550 plus VAT.

It was agreed to accept these quotes and to agree to at least three days work in the copse on the remaining ash trees that are suffering from die back, would also be funded.
